Te tātarakihi, te pihareinga, ko ngā manu ēnā o Rehua

E ngā kaihoe o ēnei waka kua hangaia ki ngā taonga o o tātou tūpuna, tēnā koutou!

Kāore e kore, the kaupapa of this summer have been rangatiratanga and kotahitanga.

In late December, Tu Tama Wahine o Taranaki released their final report on He Waka Eke Noa: Māori cultural frameworks for violence prevention and intervention. Its messages are timely.

First, it highlights the value in mātauranga and tikanga Māori, in this case, for our understandings and experiences of wellbeing and healing, and of violence.

Second, it reminds us that we will only find enduring solutions if we are clear on the source of the problem.

And third, their choice of whakataukī—He waka eke noa—"we are all on a journey together".

That kaupapa of rangatiratanga and kotahitanga have been repeated throughout this summer—from Te Paki o Matariki and the hui-ā-motu that followed, from the hui to celebrate Rātana to the hui that remember the first signing of Te Tiriti o Waitangi, and most recently in the last days of March at the Ōtautahi wānanga organised by He Roopuu Manaaki for kaimahi Māori supporting whānau to liberate themselves from

violence.

For our journey towards toiora whānau and ending violence, the kupu 'he waka eke noa' remind us to connect with and support each other in our mahi, hei kaupapa waka.
